Welcome

a. Can you tell us about a time when you felt the community spirit at [location name] really come to life? What happened, who was involved, what did it feel like?

We're going to talk about your experiences around community safety now.

5. Local Issues and safety

- a. How safe do you feel living / working in [location name]?
- b. What kind of crime related issues do you see locally?
- c. Where would you rate each issue on a scale of very significant (10) to not very significant (1)?
- 6. Let's explore 2 of these issues in more detail.

(For each issue):

Local Dynamics

- a. What is significant about [issue X] in [location name]?
- b. Can you tell us about a recent example that is typical for [location name] and how it unfolded? How was it addressed within the community?
- c. What aspects from this example would you consider to be typical for [location name]?

Current Crime Prevention Responses

- d. Would you say the way [issue X] was addressed in this example is a typical response?
- e. How successful do you think those responses are? What kind of changes have you seen as a result?
- f. In your opinion, what works well and what's doesn't with this approach?

7. Reflection

a. What crime prevention approaches or solutions would you ideally like to see in the [location name] community?

8. Wrapping Up
